The Foster Parent Recognizes That:

1. The animal is the property of **HHCR** and that it can be reclaimed at any time. Therefore, the animal cannot be treated medically, removed from the premises or given to anyone without the written release from **HHCR**;
2. The foster parent is responsible for the care and well being of the animal while it is in his/her care;
3. **HHCR** is a network of volunteers and, as such, **HHCR**, and/or any volunteer of **HHCR**, is not responsible for damages or injuries caused by the animal while in the care of the foster parent(s).

The Foster Parent Agrees To:

1. Provide the animal with a safe physical environment (free of danger from other people, animals or toxins);
2. Provide the animal with physical care and the food and litter recommended by **HHCR** at the foster parents own expense;
3. Keep the animal indoors;
4. If applicable, introduce the animal gradually - one at a time - to other members of the household, especially pets (as per documents on website "Two Are Better Than One"); hyperlink
5. Notify **HHCR** immediately if the animal becomes ill. If the foster parent contacts a veterinarian without the prior agreement of **HHCR**, the foster parent is responsible for all of the expenses incurred;
6. The foster parent will **NOT** declaw a kitten/cat;
7. Return the animal to **HHCR** if for any reason the adopter cannot keep the animal (the responsibility for the animal cannot be handed over to another foster home without prior consent from **HHCR**);
8. Refrain from fostering animals from any other shelter or rescue group while fostering for **HHCR**;
9. Provide regular updates to **HHCR** as requested by **HHCR** via email and phone calls, and accept regular visits from **HHCR** to ensure the animal's well being.

HHCR Agrees To:

1. Provide the foster parent with the animal described: _____
2. Inform the foster parent of any diseases and the level of contagion [animals with serious medical conditions will not knowingly be placed for fostering unless the nature of the condition is known to the foster];
3. Inform the foster parent of the reason for fostering and ensure **that the foster is willing to provide foster care for the length of time required to find the cat its permanent home"** ;
5. Ensure that the foster parent is informed of any minor medical conditions **HHCR** is aware of and provide the foster parent with any medication the animal is currently receiving (eye ointment, antibiotics etc);
6. Ensure that the foster parent understands and is comfortable providing any treatment the animal may require.
